



## APPLICATION AND AGREEMENT FOR MEMBERSHIP IN THE LAKE BARCROFT VILLAGE

The person(s) listed on the application attached below hereby applies (apply) for membership in the Lake Barcroft Village (the Village) upon the terms and conditions set forth below.

Lake Barcroft Village is a Virginia non-stock corporation qualified as a charitable organization under Section 501(c)3 of the Internal Revenue Code. The Village provides services to and programs for its Members through its corps of neighborhood volunteers, all of whom have undergone background checks. For any Village services as posted on the Lake Barcroft Village web site that cannot be provided by volunteers, the Village will assist Members in finding qualified providers.

### **Types of membership**

**Full membership.** Full members are entitled to all the services and programs that the Village offers as are identified in the Village Member Handbook, the Lake Barcroft Village website and other Village communications and are entitled to participate in the governance of the Village. The fee(s) for a Full Membership are \$500 for an individual and \$750 for a household. A household comprises two or three persons who reside at the same address. Fees do not include out of pocket expenses incurred by volunteers.

**Social membership.** Social members are entitled to participate in all social, cultural and educational programs offered by the Village, and are entitled to participate in the governance of the Village. The fee(s) for a Social Membership are \$150 for an individual and \$300 for a household. A household comprises two or three persons who reside at the same address.

**Alumni membership.** Alumni members are former members who have moved away from the geographical area served by the Village but wish to maintain their ties with the Village and to attend social, cultural and educational programs sponsored by the Village. The fee for alumni membership is \$50 per person.

**Membership term.** The term of membership is 12-months, effective the first day of the month following the day the Village accepts this application and appropriate payment, unless otherwise agreed by both parties. The annual fees may be increased from time to time, and annual membership may be renewed subject to mutual agreement and payment of the then-applicable annual fee.

**Termination of membership.**

**By Village.** The Village reserves the right, in its sole discretion, to terminate this agreement at any time if it determines that it is in the best interest of the Village, its volunteers, other Members or the undersigned Member(s). If the Village terminates this agreement, it will return a portion of the annual fee paid on a prorated basis from the month after termination.

**By Member.** The undersigned Member(s) may terminate this agreement when a change in living situation results in the member's leaving the geographical area served by the Village, in which case the Village will return a portion of the annual fee paid on a prorated basis from the month after termination.

**Privacy considerations.** The Village will take all reasonable steps to protect the personal information of its Members. However, where concerns regarding a Member's health or safety arise, the Village reserves the right to contact the individual(s) listed as non-member contacts or other appropriate people, as determined by the Village. In addition, to connect a Member with a third-party vendor at the Member's request, the Village may disclose contact and other relevant information.

**Hold harmless provision.** The undersigned Member(s) understand(s) that the Village is not affiliated with third party vendors it may recommend, and the Member(s) release(s) the Village from all responsibility or liability stemming from the conduct or performance of such vendors. The Member(s) further agree(s) to indemnify and hold the Village harmless for any loss, expense or liability arising out of the activities of the employees or volunteers, including but not limited to any action Member(s)' heirs and assigns or Member(s)' insurance company might bring for negligence, personal injury or invasion of privacy. Member(s) understand(s) that the Village is not a provider of emergency services or health-care services, is not a health-care administrator, and does not employ licensed health professionals or social workers. Village volunteers are not permitted to provide routine ADL (activities of daily living) care, nursing, feeding, lifting, shaving, and similar services.

This Agreement is not meant to create any special relationship giving rise to a duty to aid or protect between the Member(s) and Lake Barcroft Village.
